## Information for Applicants

### PLTC Funding Application for Articling Students

The Yukon Law Foundation provides approximately \$1,500 annually for financial assistance for Yukon articling students attending bar admission courses outside the territory. Disbursement of funds is dependent on the applications received.

The criteria for such assistance are:

- 1) Intention to return to practise law in Yukon, and
- 2) Financial need

This is not intended to replace funding normally provided by your employer to attend PLTC.

If you meet these requirements, funding may be paid directly to you. Failure to include any of the required information may result in the immediate rejection of your application.
